

## Checklist for Starting a Business

- Prepare a timeline detailing your action timetable.
- Contact the VI SBDC for assistance.
- Perform a feasibility study for your business idea:
  1. Know what type of business you would like to start and learn all you can about it.
  2. Conduct thorough research of your potential customer, trade or industry, competition, licensing and tax requirements, location, and name.
  3. Check on territory and federal regulations that may affect your business.
  4. Determine whether your business requires a Territory or Federal license or permit to operate.
- Check with the following offices for information on zoning ordinances, licenses, regulations, building permits, ADA compliance, and fire codes.

- Evaluate possible site locations. Check physical condition, suitability, traffic flow, parking, utility requirements, and cost.
- Prepare a written business plan, complete with financial statements.
- Determine which legal structure best fits your needs; sole proprietorship, partnership, limited liability company, or corporation.
- Consult with an attorney for legal issues regarding your business (if necessary).
- Contact an accountant to assist you with tax requirements and compliance (recommended).
- Contact an insurance agent and consult with him or her regarding liability, fire, accident, theft, business continuation, and/or other types of commercial insurance.

- Obtain a Federal Employer Identification Number (EIN) from the Internal Revenue Service. [You can apply for an EIN here.](#) **(Recommended, but not required for Sole Proprietorship)**

Review the following items that will need to be on file at the DLCA's Division of Licensing before a business license will be issued:

**1. Certificate of Trade Name/Partnership and Corporation Registration**

**2. Tax Clearance Letter (for renewing your business license)**

Note: All applicants for license renewal must submit a tax clearance letter showing good standing with the Bureau of Internal Revenue. This review will be conducted on applicant's behalf by the DLCA - Division of Licensing upon submission of application for new business license.

**3. Police Records Check**

Note: All applicants must submit to a Background Check from the Police Department. This review will be conducted on applicant's behalf by the DLCA - Division of Licensing upon submission of application for new business license or change of principal(s).

**4. Zoning Approval**

Note: All businesses must submit to a review by the Department of Planning and Natural Resources for zoning compliance. This review will be conducted on applicant's behalf by the DLCA - Division of Licensing upon submission of application for business license.

**5. Fire Inspection**

Note: All businesses must submit to a review by the Fire Service for fire code compliance. The Fire service will determine the nature of the review that is required for your business type.

- Barbers, Beauticians and Manicurists;
- Construction Contractors;
- Electricians;
- Plumbers;
- Public Accountancy;
- Real Estate Appraisers;
- Real Estate Commissioners;
- Social Workers
